Pre-service training is almost complete for Class #61. We are already looking for volunteers for our next class which begins on April 19, 2022.

Once volunteers are sworn-in, we continue to offer educational opportunities in order for advocacy skills to be enhanced. National CASA requires active volunteers to complete 12 hours of continuing education per year. Jenny has conducted the first in her series of four TBRI in-service classes for 2022. We are also offering Lunch and Learn sessions on a variety of relevant topics. (see the training section for details).

The month of March always brings new life. Our staff is weary of restrictions from both the pandemic and the hurricane and is ready to engage with the community. TBRI: CONNECTING PRINCIPLES

Trust-Based Relational Intervention (TBRI) is an attachment-based trauma-informed intervention that is designed to meet the complex needs of vulnerable children. Often, children from hard places tend to retreat from relationships with others as a form of fear or distrust. In TBRI®'s connecting principles, the focus is to meet a child's need for relationships through awareness and playful engagement.
