When his friends aren't available, Tim likes to deliver his delicious delicacies right to their front door. When he tries new dishes, Tim's neighbors are his taste testers and he will bring piping hot plates to the fence for them to try.

Tim is single but he is a super proud uncle. He prides himself on being the fun, goofy uncle to four nephews, one

niece a great-niece, and a greatnephew. Tim said the hardest thing he has ever had to go through was losing a nephew and a niece. He said he always reminds himself of all the fun times they had together and all the stories of being together.

Not only is he the fun and goofy uncle, but Tim also enjoys being goofy with his friends. He enjoys telling stories and no one knows if he is being truthful or not. Although Tim doesn't have pets of his own, he takes care of the neighbor's dogs when they are gone. He encourages you that CASA staff is always there when you need help. You can also collaborate with other volunteers so that you are never alone. It gets easier with passing time. You can partner up to get started then eventually venture out on your own. Tim was able to push past his fear and anxiety and claims it becomes easier with passing time.

At CASA of Terrebonne, we like to celebrate anytime a child is placed into a safe and permanent home. National Parents Day is celebrated on July 28. We would like to take the time to celebrate the biological parents who are currently working diligently on their case plans to be reunited with their children. Statistics have shown that some children do best when they are reunited with their biological parents. Most of these parents have addressed the issues that caused their children to be placed in state custody so that they can be part of their children's lives again. Of the cases, CASA has been part of during our fiscal vear (July 2020 - June 2021) 18 children have been reunited with their biological parents. Our advocates work with the biological parents to monitor their progress with their case plan to ensure that their CASA child will return to a safe home. Our hope for these kids is that they are returning to a safe and happier home.

Similarly, we also want to celebrate the foster parents who have opened their homes and stepped up to care for these children while the bio parents are working to better themselves. Over the last fiscal year, 14 foster homes have become forever homes for 25 of our CASA kids. Our mission at CASA is to advocate for the safest placement for the kids we serve, however the outcome.

Lastly, July is the time of year when we celebrate our country with fireworks and get-togethers. Children are celebrating the freedom of school and many families enjoy trips together. Family and community are such an important part of the fabric of life here in Terrebonne Parish and at CASA of Terrebonne. However, the thought of family may not bring happy memories to mind. Many are spending their summer in State's custody, away from everything and everyone familiar to them.

We are asking you to help us and become part of our community for change in a foster child's story so that these kids can thrive. Our summer pre-service training class beings July 13, 2021. You can learn more and apply to become an advocate on our website at www.casaofterrebonne.org.



In the TBRI® model, this term describes the attention to addressing the physical needs of a child and their felt safety.
