When looking through the various "special" days in March, this one stuck out to me. You guys do not need a special day to be heard. You choose to stand up and let the judicial system hear your voice for the children that often do not have a voice of their own. This is why the work that you do is so very important. It is the reason we strive for 100% of our children to be seen every month and have the expectation that the contact logs will be detailed. We want to make sure that your voice echoes as loud as it possibly can so that justice can be served for our children. We want each of our children to have the best possible outcome with the situation they find themselves in. So let your voice ring out loud and proud! You are a child's advocate and for that, you are a superhero!
