Silvana Santos-Alegria was sworn in as a CASA volunteer on 12/20/2017. On 1/16/2018, she was assigned to her first case of 3 children, a school age child and a set of infants. From the moment she was told you are assigned, Silvana took those childrens' lives and best interests to heart like they were her children. She immediately took the information and began to analyze where her advocacy would be needed the most based on the childrens' ages. Silvana made contact with all family members and care providers. She went into every visit with a blank canvas and an open mind.

Silvana always makes people feel like they matter regardless of their choices. She provides information and gives suggestions to resolve basic issues and information on how to follow up with current situations. From the beginning of her case she noticed some educational deficits with the oldest child so she called a meeting to hold everyone accountable for what was occurring. During this meeting they were able to provide additional services and she was able to provide information to the teacher about the child's recent transition from being with her parents to being in a relative placement. Not that she wanted sympathy for the child, but she wanted them to understand what this child was going through. During Silvana's visits she made sure that she reviewed sight words, but she also made time to play fun games or just have girl time, and also note the babies' progress through observation and play. The school year ended and there was progress.

As the new school year rolled around, Silvana requested a meeting with the new teacher after the first 9 weeks to inquire about her CASA's progress or lack of progress. As a result of her advocacy, her CASA child is now part of the School Building Level Committee (SLBC). Silvana continues to work with her CASA children. She often encourages the older child to read to the little ones, which they love. Silvana has a way of turning any situation into a positive one. Although she is still working on mastering the English language, her vocabulary and writing skills are incredible. Silvana will write out detailed emails and send them to DCFS, teachers, counselors and her CASA supervisor to make sure everyone is held accountable.

We recently received a call from a Judge requesting a CASA on a delicate case. The office immediately thought of her, because of her personality and level-headed decision making. When she was approached about it, she agreed. She knew that there would be a lot of work to be done in a short period of time. The same day she was assigned she made a visit with her CASA child and made arrangements in her personal life to make sure she visits with all of the parties prior to court. We are grateful that she is part of our CASA family. Silvana will be receiving a donated polo shirt by Shelly Toups at Artistic Embroidery.
