Becoming a CASA can be a scary endeavor. We work in some very tough situations and with people who come from rough backgrounds. It can be mentally exhausting scouring through all the information regarding your chosen child or children. However, something that we have found very beneficial not only to the new CASA volunteer but to our program, is to partner up with someone and be assigned to multiple children. We have several partnerships within our program, but this month I want to spotlight a very special partnership. Not only are they partners in CASA, they are partners in life: Carol and Blayne Bergeron, advocates of the month for October 2018!

This duo features a leading lady, Carol, whose profession is to make people feel beautiful through transforming their hair in color, cut or style. Carol swore in on May 2nd 2018. It also features Blayne, a man of many personalities. As his supervisor, I have to brace myself when he calls because I am never sure which Blayne I will get. Will it be rock star Blayne? Will it be undercover agent Blayne, who will make me question everything I know to be true? Or will it be the big teddy bear Blayne? Either way, I know that the phone call will be an important one regarding either of his cases. That is correct. Blayne is actively working two cases. He swore in on August 19, 2015. We already knew which case we were going to present him with as we needed his expertise on the case. He readily took the case and has made tremendous progress. Then when his wife decided to become a CASA he willingly took on a case with her as well. They accepted their case together on May 7, 2018, and quickly got to work. From my understanding, Blayne directed and guided Carol through the process but allowed her to do much of the hands-on work so that she would become comfortable with the system and individuals involved. She became so comfortable with the system that she testified at their last court hearing and did a phenomenal job. Their case closed on September 18, 2018 with reunification. We congratulate them on a job well done.


