She worked hard every time she was placed in a new school due to her failing grades. She made call after call to get her CASA child the helped she needed. She visited the child continuously and at one point she was often called (sometimes daily) from the foster parents to discuss day-to-day issues. She was the voice of reasoning and often the families would bring the child to the library where Rushelle would try to smooth things over. This case closed due to the mother regaining custody. Rushelle again wasted no time and on 4/12/2017 she was assigned to another case which today she continues to advocate for. Although this case is less demanding,


