A native of Montegut, Gina is active in her community by serving in youth ministry at her church, coaching T-Ball in the summer, cooking, crabbing, and enjoying family game nights with her cousins. Whether she's in court, church, or on the T-Ball field, you can bet she is wearing her trusty Crocs. Gina is a huge fan of Crocs and has a pair for any occasion. "If you ain't Croc'n you ain't rock'n" is something she often says.

Gina has been active with CASA since 2019. She became interested in the organization when she began to read information on the role of a volunteer. After a lot of reading and praying she applied and started her training. In the past three years, she has advocated on three cases all of which have closed. When one of her cases reopened recently she was ready to take it on and reconnect with the children. Gina encourages anyone interested



in the CASA organization to share their time, talents and treasures with those in need. It truly takes a village. When asked for something to share, she wrote:

# A MESSAGE FROM JENNY DOMANGUE

LEAD ADVOCATE SUPERVISOR

As I sit here and reflect on the last year, I can't help but feel an overwhelming sense of gratitude for each of you.

To our volunteers - We have had a long, hard two years between COVID and Hurricane Ida; but we have come through triumphantly. I believe we are finally coming into the clearing after wandering through the dark woods for so long. You all have stuck by our side and endured the hard times with us. I am so thankful for our volunteers. You have flowed ever-changing demands, protocols, procedures, and expectations. Some of you had to search for your CASA kids after Hurricane Ida while dealing with your own families, homes, and businesses. You continue to show up month after month and amaze me with the lengths you will go to for your CASA kids and families. I have seen you put your own lives on hold to be available to help. I have seen you living out of your cars after the storm but still concerned about making sure your CASA child had everything they needed. I have seen you make calls and send emails while in the hospital for your own medical issues and apologize for not being present. If that's not dedication, I'm not sure what is. Without you, we, the program and staff would not have any reason to exist. So this holiday season, I know that Ole Saint Nick has something special just for you because you have earned a place on the nice list for life!

To our supporters - You have continued to show up for CASA even through uncertain economic times. We never feared that our doors would close because even though other businesses were suffering you still donated goods, time and money.

There are no words to adequately describe what that means to our organization and ultimately our CASA kids. Without the support of you all, CASA would have to cut way back on the things we do for our community and the kids we serve. You make those "extras" for our kids possible. Thank you to anyone who has supported our organization this year in any way.

To the CASA staff - When I started 11 ½ years ago, the average length of employment for a CASA staff member was 3 years. Some staff lasted just a few months, some a year or two, but to still be around after 3 years was something almost unheard of. Our staff today has been here an average of 7.5 years. I, Jenny, have been with CASA for 11 years. Sulma has been with CASA a total of 8 years. Christine and Valentine both became an advocate and then were hired as staff and both have been here for 6 years. Anna has been with us for 4 years and our newest staff member, Eddie, has only been on staff for a few months but has been an advocate for 12 years. I believe this speaks volumes to the dedication and loyalty that our staff have to the mission of the program. We hope that both our volunteers and our community partners see and understand that we are here for the long haul. We want to see our community come back to vibrant life and we are here to be a part of it.

As we all go through this holiday season, know that you are all appreciated beyond what words can describe. Our organization depends on all three aspects to run as smoothly as we do. The staff is the vehicle in which we move, our volunteers are the motor that runs the vehicle, and our community partners are the gas that powers it all.
