Know that it is a commitment and that there are sometimes more sad days than happy but you will be positively impacting a child's life. You can make a difference". Christian's goal as a CASA is to be a male role model to older boys who may be missing that aspect in their lives.

A Day of Kindness

February is a month filled with several awareness days and holidays. It is Black History Month, American Heart Month, and National Cancer Prevention Month to name a few. February also has Valentine's Day, the Super Bowl, and in the South, we have Mardi Gras. This year, on *February 17th*, we have Random Acts of Kindness Day!

Here at CASA, we love random acts of kindness. Whether it's one of our sweet advocates sending us cookies or other goodies, bringing one of their CASA kids something to brighten their day, or leaving a post Sometimes just showing up monthly to visit a CASA child, being that constant for them through their time in foster care and being their voice in court, may increase that sense of trust more and more in a child's life. We don't always get to see the fruits of our labor, but planting that seed of kindness goes a long way, especially in a child who doesn't get to experience that as often as they should.

My supervisor, Jenny Domangue just did a training on TBRI (Trust Based Relational Intervention). It teaches us about rewiring our brains to overcome past trauma. It changes the way we look at and deal with everyday issues. Doing random acts of kindness is a great way to rewire our brains to be more positive.

So, this month I encourage you to begin or continue doing random acts

Studies have shown that acts of kindness can not only improve the physical and mental health of the person receiving the kindness but also the person showing the kindness. Being kind boosts serotonin and dopamine, which gives you a feeling of satisfaction. Receiving kindness can increase oxytocin, which is responsible for feeling an increased sense of connectedness, an increased sense of trust.

of kindness! Send someone an encouraging note, tell your coworker they are doing a great job, pick up litter at the park, or sign up for our next training class to volunteer to be a CASA. No matter what you do, do it knowing that you may make a difference in someone else's life, as well as your own, and it may even encourage others to do it as well.
