ADVOCATE'S CORNER

April is National Volunteer Month. Here at CASA, that is what it's all about. Our advocates volunteer their time to help a child in need. People often want to give back and volunteer in their community, a feeling that they could be doing more. That is what I was looking for when I was introduced to CASA six years ago. I was a single working mom of two with a very busy life, but I couldn't shake the feeling that there was more I could be doing, something to help. I was talking to a friend of mine about wanting to do more for my community. I wanted to help and give back to someone who may be in need. While discussing some possibilities I was looking into, he told me his wife volunteered at CASA and loved it. I wasn't familiar with CASA, but I had seen the logo around town and had wondered what it was all about. When I called, there was a training class that was about to begin. I attended the orientation and instantly fell in love with the program!!



CASA plays such a crucial role in a case. There are so many moving parts in a case. The parent's attorneys are fighting for what the parents want, the child's attorney is fighting for what the child wants, and the state is making a recommendation based on the whole family. What I loved about CASA is that not only is CASA a voice for the child in court when so many are trying to decide what's best for them, but CASA is also advocating for the best interest of the child. CASA presents fact-based recommendations based on what is best for the child. Yes, we give them a voice in court, and that is very important because they deserve to have their voice heard; however, sometimes what they want is not always in their best interest. My child would love to have ice cream for dinner! While I do sometimes give in and she gets her ice cream, it is not until after she has had her proper dinner. Believe me, my children have no problem using their voice, but what good is that voice if no one hears it. As a parent, and as a CASA, I have listened to my children. Whether it is letting them know that I acknowledge that my son wants to negotiate his bedtime and we work it out, or that I let my CASA child know that I will tell the Judge that she wants to be with her sister. Children are our future, and sometimes for a child in the foster care system, a CASA is the only constant in their life, their only voice. And while we don't make the final decision in their case, we can bring their voice and their best interest to the Judge to help them make the most informed judgment for that child.

I know I have been blessed in my life with amazing friends and family. I have always wanted to do something with my life that helped people in need. I had no idea becoming a CASA volunteer would lead to my career as an Advocate Supervisor, but I am so glad it did! Volunteering, and now working with CASA, has been one of the most rewarding things in my life. That is not saying that there aren't ups and downs in the process, but I never want to lose focus on why I chose to volunteer. I chose to volunteer to make a difference, and while I would love for that to happen overnight, I know it doesn't. As a supervisor, I have seen the good and the bad, and both make me want to fight harder to continue to make that change, to make that difference. Thank you so much to all of you who are already volunteering, and for those wanting to do more this National Volunteer Month, be a voice, be a CASA.

In TBRI®'s connecting principles, the focus is to meet a child's need for relationships through awareness and playful engagement.
