November is adoption awareness month. Adoption days are the days that we look forward to most here at CASA of Terrebonne. A lot of times it is a **LONG** process that comes with plenty of twists, turns, and cartwheels. We all strive to make the process as smooth as possible for not only the birth families but for the foster/adoptive families. Most importantly our goal is to help a child achieve permanency as quickly as possible whether that is through reunification or adoption.



As we are all facing tough times, our most vulnerable children who need a safe and stable home are still very much in need. There are not enough foster homes for our children. We have heard stories in the past of DCFS not being able to find a home for unruly teenagers. However, just recently our local DCFS could not find a temporary home for an infant. Infants are typically very easy to place because everyone loves babies. But foster homes are filled to the brim and unable to take more children. There is a dire need for kind and loving individuals to open up their homes to these children who so desperately need some love and understanding.

We also celebrate when parents work hard and accomplish their case plan goals and can be reunified with their children. This takes a lot of hard work and dedication on their part. We often say we don't promise kids Disney World, we promise them a safe and stable home. If their parents can provide this then that is where they need to be.

CASA's play such a huge role in both of these outcomes. The observations and interactions that build your court report to the judge are influential in the judge's final decision. Your relationship with the child will be one that they can look back



on and realize that you were their support system through it all. Make your mark, make your presence known and help these kids get through some of their toughest days. Sometimes I feel like we lose sight of the difference we are making when judgments don't go the way we feel they should or teenagers rebel against everything put in place to help them. But just know that seeds do not grow overnight. They take time. And just like you don't see the fruit of your labor instantly in gardening, with our CASA kids, you may not get to see the difference you are making now but someone will notice it in the future. We have to stand on the fact that you are making their life better with every visit. You are teaching them that there is at least one reliable person in their corner. *Keep fighting the good fight*!
