Oh sweet September, you showed up just in time to give us a break from all of the chaos of running around or browsing the internet to purchase uniforms and school supplies for our kids to start a new school year. As stressful as that is when you have multiple children, there is such an accomplishment when you cross an item off the "optional" supply list. And just when you think, thank God the kids are all back in school and I can finally breath, you are quickly reminded that with school comes homework, projects, and additional issues that children will face in school that may challenge their selfworth and existence. We should not be naive to the fact that children are being ridiculed by peers for the way they look, their behaviors and disabilities or their poor academic grades.

Due to our line of work, we know that children from unstable homes will face obstacles that they have no control over. Many of those children can only take so much before they start to have negative thoughts and question if life is even worth living. As Advocates assigned to these vulnerable children and families, I urge you to be present during your visits and actively listen to their concerns or fears. Be proactive and ask questions about their day and their friends. . Let's be compassionate with those involved in the case and provide them with words of encouragement because life is not easy even for those who have stepped up to help an overwhelming system. Even those that seem to have it together can use words of encouragement. At times, I personally struggle with life and think twice about every decision I make for

my family because let's face it 2021 was not a good year for many of us with COVID and Hurricane Ida to name a few. Fortunately for me, I have people who can lend an ear or help me when I am about to lose it. However, many are not that fortunate.

September is the month for Suicide Prevention and Awareness. This month comes packed with information for those who are in the midst of grief or thoughts of taking their life. Mental health is real and temporary problems are sometimes overwhelming, and the only solution for some is unthinkable. Many of you may know that the Suicide & Crisis Lifeline changed its toll-free number to 988 in hopes of making it easier for individuals to remember. So as September peeks in, remember those who have been affected by suicide. Continue to practice self-care and use those techniques that were given to you at Revive your Inner CASA. Remember that when life becomes overwhelming, we are always here to help even when it's not case related.

QPR Gatekeeping Training: Suicide Prevention

Tuesday * September 27, 2022 * 6 pm - 7:30 pm (1.5 Credit Hours)

QPR Gatekeeper training is evidence-based and teaches participants how to recognize the warning signs of someone thinking about suicide and how to get them help. We cover facts and statistics, myths, warning signs, how to ask someone about suicide, and how to get them help. Participants receive a 2-year certificate and many resources. In-Service: TBRI Correcting Principle

In the fourth and final installment of our TBRI® In-service training series, Jenny Domangue will present the TBRI® Correcting Principles which aim to address a child's behavioral issues in a positive way. Two important principles in the correcting component are proactive and responsive behavioral strategies. Although CASA advocates are advised not to use these Principles with their CASA children, they can still use the information in their own lives and have a full understanding of the TBRI® model.
